

#### MING Shipwreck Artefacts by

## Asean Heritage Museum Group

The 8 pieces of rare Ming Shipwreck artefacts belong to the Asian Heritage Museum (AHM) Group based in Kuala Lumpur. These authenticated artefacts are part of a large and diverse collection of Asian and geological artefacts, which was acquired legally via a Kuala Lumpur High Court Order in 2010 in lieu of a large debt owed by a foreign explorer who absconded.

AHM has recently, secured the tenancy of the iconic national heritage site, where most of the Constitution was written between 1955 to 1957 and which the Merdeka (Independence) Agreement of Malaya was signed on 5 August 1957.

In September and October 2017, AHM has organised the Jalan Merdeka (Road to Independence) Exhibition, with a very comprehensive perspective of Malayan history up to Independence, at Carcosa and Seri Negara in conjunction with the Department of Museums Malaysia, National Archive, National Film Board and the New Straits

Based on its own collection of diverse and museum quality artefacts, AHM intends to set up a world-class and innovative heritage and peace museum at Carcosa. It is also setting up an artefacts trading & exhibition and performing arts centre at Seri Negara.

The Advisory Council of AHM comprises eminent public personalities such as minister Datuk Seri Dr Wan Juanidi Tuanku Jaafar, writer and think tank founder Tunku Zain Al-Abidin Tuanku Jaafar, economist and former senior civil servant Tan Sri Ramon Navaratnam and Dean of Faculty of Medicine, University of Malaya and Chairman of Malaysian Aids Council, Prof Dato' Dr Adeeba Kamarulzaman.

AHM has decided to sell off some of its artefacts in order to raise some capital to further fund the repair, restoration and refurbishing of Carcosa and Seri Negara and to set up the heritage and peace museum and arts centre. Senior officials of a leading government-linked auction house in China, visited AHM in Kuala Lumpur from 22 Sept to 24 Sept 2017 and selected many similar Ming shipwreck artefacts for the coming autumn auctions in Beijing in December 2017.



"Purchase Price" means the total amount payable by Buyer for his/her/its bid, including Hammer Price, commission (Buyer's Premium), Goods and Services Tax (GST) (if applicable) and other expenses payable by the Buyer.

"Reserve Price" means the lowest selling price of Lot determined by the Seller and confirmed with the Auctioneer in the consignment auction contract.

"Indicative Price" is a preliminary estimate of an initial bid provided by the Auctioneer, which is neither firm nor binding (if any).

#### 2. THE AUCTIONEER

- 2.1 The Auctioneer reserves the right to regulate the bidding with absolute discretion and shall have its sole right to refuse any bid or bids without giving any reason for such refusal. The Auctioneer reserves the right to alter or add to these Conditions at any time prior to the sale.

- 5.8 Lots sold are shown with all faults and imperfections. Neither the Auctioneer nor the Seller shall give any warranty to any Buyer in respect to any Lot or be liable for any fault or error of description or lack of genuineness or authenticity of any Lot.
- 5.9 Subject to Clauses 5.7 and 5.8, the Buyer must satisfy themselves as to the accuracy of their purchases at the time of the delivery of the Lot. The Auctioneer cannot be held responsible for any discrepancy which might be discovered after the Lot has been duly accepted upon delivery.
- 5.10 All grading, statements or descriptions as to the Lot, whether made in the Catalogue, website, during the course of auction or otherwise are opinions only and shall not be taken to be statements or representations of facts or warranties of any kind.
- 5.11 References in the catalogue entry or the condition report to damage or restoration are for guidance only and should be evaluated by personal inspection by the bidder. The absence of such a reference does not imply that an item is free from defects or restoration, nor does a reference to particular defects imply the absence of any others

#### 6. UNCERTAINTY OF CATALOGUE

- 6.1 In case that the tone, colour, gradation and shape shown in Catalogue and/or any other illustrations, images and public materials differs from those of the original Lot due to print, photograph and other technical reasons, the original shall take precedence.
- 6.2 The publications quoted in any explanation of the Lot by the Auctioneer are only as reference for the Bidder. The Auctioneer shall undertake no liability for any inaccuracy or omission in the statements as mentioned in the Catalogue.
- 6.3 No Lot may be returned after full Purchase Price has been made.

#### 7. POST (AFTER) AUCTION

- 7.1 Immediately after the fall of the hammer and upon being declared the successful purchaser of the Lot, the Buyer shall be served a Tax Invoice stating the Purchase Price to be paid.
